4. Trustee names—ask Leilani if someone needs to go in person to the Bureau of Conveyances in Honolulu to get this information

- 5. A yearly independent audit is needed. Glen B contacted a former Aloha Estates resident who is a bookkeeper to ask if she would like to do this
- 6. Cutting roadside bushes Glen B will contact Dwayne (Huki Pau)
- 7. Picture and short bio of Shelly P, Glenn P for the website

- 2. Shelly asked if it was OK to send a Neighborhood Watch picture to Manuel on 2nd Road or to any residents so they can make their own NW banner to hang on their own property fence or gate yes
